- (b) on any day that music and dancing end between midnight and 01:00 hours, the permitted hours shall end when the music and dancing end.

(2) In relation to the morning on which Summertime begins, paragraph (1) of this condition shall have effect with the substitution of references to 02:00 hours in the morning for references to 01:00 hours in the morning.

(3) On New Year's Eve the permitted hours shall extend through from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day.


